ED HUNZEKER BRINGS HOME THE REALITY OF LOCAL GOVERNMENT IN A RECESSIVE ECONOMY

Our members who attended the last luncheon meeting of the season were treated to a frank discussion of the impact of a troubled economy and a state government that insists on pushing tax increases onto local governments.

Ed Hunzeker, the County Executive of Manatee County gave a no-holds-barred presentation to the

Club at our May luncheon meeting. An accountant by training and a veteran of 40 years of service to county governments, Hunzeker has served the St. Louis County Government and the county governments of Hillsborough and Osceola Counties in Florida, where he emphasized the importance of budgeting.

Hunzeker gave perspective to the issues facing county governments by describing the state's forcing Manatee County to build and finance a new state courthouse for \$80 million and then pay

for the court's computer network. This is at the expense of quality-of-life services, such as schools, parks and environmental preservation—the services that set a county apart from others. He bewailed the fact that the state loads its budget increases on the counties and now has capped their ability to raise taxes to cover the increases.

He described the conversion of a budget process that involved presentation of the budget two weeks before it needed to be adopted to a process in which the proposed budget will be presented at the beginning of June and the county government will discuss it intensively for the entire month. He noted that the budget covers 74 programs. He walked us through

the \$1 billion budget to show that less than \$150 million is at all discretionary. He explained his approach in reviewing every budget request to determine what it would provide for the taxpayers.

Hunzeker noted that Manatee County will try to expand its public transportation system at a time when there is increasing demand for its services. He noted, however, that support for nonprofit

organizations that provide social services to the community will have to be cut, even though this is not the right time to make such cuts. He suggested that government funding should be countercyclical; in other words, during economic downturns the government should step in to reduce the impact on its citizens.

He then descried as senseless and counterproductive the situation

in which real estate property taxes fall disproportionately on

businesses and "investors," the snowbirds who own second homes in Florida.

As an example of his approach to the partnership between the county government and the private sector to reduce costs and provide greater employment opportunities, Hunzeker described his county's efforts to fund necessary roads by persuading private contractors to undertake the construction at lower rates than during boom times. This gives employment to the construction sector and enables the county to obtain needed infrastructure at less than a premium. Eventually, the county will purchase the improvements.



I have been interviewing candidates for the past five years under the direction of Wes Finer, who has been our superb Chair of the Alumni Student Committee. However, I am not certain that many qualified students are even aware of Yale or its recently revised financial grant programs. 
