## USF INTERNATIONAL AFFAIRS CHAIR EXPLAINS US-IRANIAN AFFAIRS

Dr. Mohsen Milani, the Chair of the Department of Government and International Affairs at the University of South Florida, held the auspiciously large audience spellbound at our first speaker's luncheon of the season at Marina Jack. Born and raised in Iran only a five-minute walk from the US Embassy that was the scene of the

horrific 1979 kidnapping of embassy personnel, Dr. Milani was sent by his father to California at an early age. He obtained his Doctorate from the University of Southern California and has spent the past twenty years at USF with stints at Oxford and Harvard.

Both Peter French, who introduced him, and Dr. Milani described his job as one of the more difficult around, since political science professors are difficult

to control. Or, as Dr. Milani described it, the only difference between terrorists and political science professors is that terrorists are sometimes willing to negotiate.

Dr. Milani began with the observation that, in order to understand the world, it is important to understand how others view it. He stated that President-Elect Obama's background has given him the ability to empathize, which is crucial to being able to understand the views of others.

Dr. Milani described the origins of the present conflict between the U.S. and Iran. He noted that, prior to the 1979 revolution, Iran was the largest purchaser of

U.S. weapons. Approximately 50,000 Americans were in Iran, and a similar number of Iranians were in the U.S. He portrayed Ayatollah Khomeini's overthrow of a monarchy of 2,500 years to create a Moslem republic as the most popular revolution of all time. The action of a group of rash students in taking embassy

employees hostage created intense distrust and enmity among Americans. In fact, the U.S. and Iran have since then had no formal diplomatic relations for the past 30 years.

Dr. Milani then explained the Iranians' grievances against the U.S. and how Americans look at Iran. He stated that Iranians resent the U.S. for meddling

in their affairs and in playing off Iran and Iraq during the eight-year Iran-Iraq war, supporting whichever side the U.S. felt did not have the upper hand rather than supporting a cessation of hostilities. The Iranians also resent the freezing of the Iranian government's assets in the U.S. Part of the dispute is over just how much of such assets there are. He noted that the Iranians have been selling carpets for 2,000 years. His comment promoted a recollection of George Ball, who over thirty years ago commented to Suzanne and me that the Shah was little more than a carpet trader. The most important issue to Dr. Milani

is the perception in Iran that the U.S. Government is pushing for regime change in Iran. Iranians think that the U.S. was moving to take action in Iran right after the pacification of Iraq and was delayed only by the Sunni insurgency in Iraq. He pointed to Congress' appropriation of hundreds of millions of dollars for the overthrow of the Iranian government and our

government's funding of groups opposed to the Iranian government as inflammatory actions.

American concerns include viewing Iran as the main sponsor of international terrorism through providing logistical and financial support to terrorist organizations and Muktada Al-Sadr's militia and resentment over Iran's derailing the peace process sponsored by the U.S. in the Middle East. Americans also view Iran as a theocracy oppressing its opponents, constantly violating basic human rights of its own citizens. The most important American gripe, however, is the perception that Iran is building a nuclear weapon. Iran takes the position that enriching uranium is an inalienable right of any nation in today's world. Iran claims that the U.S. has

double standards: Its friends (including India, Pakistan, Israel and Russia) may have nuclear weapons, but Iran may not. The U.S. realizes that a nuclear Iran is going to change the balance of power in the Middle East for decades. Dr. Milani thinks that Iran does not necessarily want to build and own a nuclear bomb but rather the infrastructure and knowledge to build a bomb in case they want to. He views this as a policy of deterrence.

While he would not want to live under the leadership of Iran's Islamic Republic, Dr. Milani stated that he does not think that Iran's leaders are much different from the leaders of other countries. He pointed to a 2007 National Intelligence Estimate that presented two conclusions based on the consensus of 16 intelligence

agencies: (1) Iran halted its nuclear weapons program in 2003, and (2) the decision to halt the program was based on a cost and benefit appraisal. He pointed to other Iranian actions that reflected the cost-benefit approach, namely, support of the overthrow of the Taliban in 2003, support of the current government of Iraq and support of the Orthodox Christian Armenians against the Shiite Azeris of Azerbaijan.

Dr. Milani posited that President Bush's actions in getting rid of Saddam Hussein in Iraq and driving out the Taliban from Afghanistan had done for Iran what it could not do for itself. The result of these actions is a much stronger Iran today than eight years ago. It is now a powerful player in Afghanistan and Iraq, and its investment in Lebanon has paid off handsomely.

Dr. Milani insisted that it is essential for the U.S. and Iran to talk without preconditions. He stated that we cannot change the regime and must recognize that Iran is an Islamic republic, Islamic being the operative word. The Ayatollah is the most powerful leader, but his principal task of maintaining a political balance of the many factions within Iran is not easy.

This thoughtful presentation was a truly auspicious inauguration of what promises to be a very exciting season of luncheon speakers.


Just before sundown, President Brian T. Kelly addressed the throng. He stated that the purpose of the party was to thank the faithful members for their


bartenders assured that no one went without proper Kick-off Party care.




## Alumni Schools Committee Breakfast




#### **Our Members Make News**
